

# Portable Operations Challenge Rules

## **CONTEST OBJECTIVE:**

For portable and fixed stations to work as many other portable and fixed stations as possible during the contest period.

## **CONTEST PERIOD:**

The contest is 12-hours long, consisting of three 4-hour periods on September 4 & 5, 2021 UTC.  
The sessions are:

Session 1: 0800 – 1159 September 4, 2021 UTC  
Session 2: 1600 – 1959 September 4, 2021 UTC  
Session 3: 0000 – 0359 September 5, 2021 UTC

Stations may be worked once per band and mode by session for a maximum of 15 contacts between stations per session (possible of 45 contacts for the 3 sessions together). Duplicate contacts will be removed without penalty.

N1MM+ users need to create a new log for each session for N1MM+ to properly score each session.  
N1MM+ users must also set their power used in the power field of the “Change Your Station Data” in the Config Menu for proper scoring. This power value will apply to all QSO’s logged.

Scoring will be done by each individual session. Participants may operate one, two or all three sessions.

Overall champion will be determined by aggregating scores from the three separate sessions. The Individual with the highest aggregated score will be crowned champion.

## **BANDS:**

80, 40, 20, 15 and 10 meters

## **MODES:**

CW, Phone (SSB), and Digital

Digital mode is any data mode that can transmit the required contest exchange.

Cross mode contacts are not permitted.

## **EXCHANGE:**

4-character Maidenhead grid square

## **SCORING:**

Total score for the session is the sum of all QSO Values in the session.

QSO Value = (Mode Points) X (QSO Type Multiplier) X (Kilometer/watt Multiplier) X (# transmitter modifier)

Mode Points:

Digital	2 points
CW	3 points
SSB	4 points

QSO Type Multiplier:

- Class F to Class F - 2
- Class F to Class P - 3
- Class P to Class F - 3
- Class P to Class P - 4

Kilometer/watt Multiplier

Kilometer distance between the two grid square centers divided by power used for the contact. Value to be rounded down to the nearest integer. Values less than 1.0 shall be rounded to 1.0.

Power used for the contact to be determined to the nearest watt.

When both stations are in the same grid square 71 km shall be used as the distance.

# Transmitter modifier

- 4 – 1 transmitter
- 2 – 2 transmitters
- 1 – 3 or more transmitters (Unlimited)

**CATEGORY STATION:**

Portable “P” and Fixed “F”

PORTABLE – “P”:

A station that does not use any permanent amateur radio infrastructure. Mobile operation within the same 4-character Maidenhead grid square is allowed in this class.

Stations in this class must append their callsign with /P including mobiles.

Fixed – “F”:

Fixed station with permanent installed antennas and permanent power in one location. All antennas, transmitters and receivers must reside within a 500-meter diameter circle.

Rules applicable to both classes:

An unlimited number of transmitters may operate from the same location concurrently under the same call sign. The maximum number of transmitters used concurrently at any time determines the Transmitter Modifier value to be used for scoring calculation.

The station must be operated under only one callsign for the duration of the contest.

The power used may be changed for each individual contact and must be reported correctly in the log.

Use of spotting networks and the Reverse Beacon Network is permitted and encouraged. Self-spotting is permitted.

Digital modes scripting is allowed; however, you may NOT run a fully automated station. Operator intervention to start and finish the contact is required.

All stations, including portable and mobile stations, must operate from within their chosen one 4-character Maidenhead grid square for the duration of the contest. All stations must operate their chosen category for the duration of the contest.

The DX Code of Conduct and Contester's Code of Ethics are to be followed.

**LOG FORMAT – Cabrillo 3.0:**

The file format is Cabrillo v.3.0. See <https://wwrof.org/cabrillo/> for details.

The Cabrillo header must include the following information:

- Callsign of station:

- Category-Band: All
- Category-Mode: Mixed
- Category-Operator: (field content ignored unless Checklog has been entered)
- Category-Station: (Portable or Fixed)
- Category-Transmitter: (One, Two, 3 or more Unlimited)

- Address:
- Email address of station/operator:

Individual QSO line entries:

- Frequency to the nearest kHz or generic band frequency as per Cabrillo specification
- Mode (CW/PH/DG)
- Date in UTC
- Time in UTC to the nearest minute
- Sent callsign
- Sent 4-character Maidenhead grid square
- Received callsign
- Received 4-character Maidenhead grid square
- Power used for the contact to the nearest watt

**SUBMISSION OF LOGS:**

All logs must be submitted electronically. Paper logs and scanned images of paper logs will not be accepted. Paper logs must be converted to electronic format prior to submission. N1MM+ users may submit individual logs by sessions.

Log files are due not later than 7 days after the end of the contest, September 12, 2021, 0359 UTC. Turn on the email return receipt option to receive a confirmation the log file has been received.

Non-conforming logs may be used as check logs and will not be scored.

**AWARDS:**

Grand Champion & Distance Champion

If an entrant is unwilling or unable to agree to all of the foregoing, the entrant should not submit the entry or should submit the entry as a checklog only.
